The Small Cap Value strategy seeks capital appreciation primarily through investments in equity securities of small cap companies and may invest in foreign (non-U.S.) securities. The typical market cap range of the strategy is consistent with the market cap range of the strategy is consistent with the market cap range of the Russell $2000^{\textcircled{M}}$ Index. Accounts with significant cash flows ($\ge 10\%$ of beginning of the month assets for the periods January 1, 2006 through December 31, 2010, and $\ge 25\%$ effective January 1, 2011) are excluded from the respective month's composite calculation and included in the subsequent month. Indexes: The Russell 2000[®] Value Index ("R2000V") measures the performance of those Russell 2000[®] companies with lower price-to-book ratios and lower forecasted growth values.
