Forward Price/Earnings (FY2) is the projected P/E ratios of the companies invested in the portfolio, which ratios represent current market price per share divided by a company's estimated future earnings-per-share. Projected earnings are consensus analyst forecasts; actual P/E ratios may differ from projected P/E ratios. Price/Book is the price of a stock divided by its book value. Market Capitalization of a company is calculated by multiplying the number of outstanding shares by the current market price of a share. Turnover is an annualized rate found by dividing the lesser of purchases and sales by the average of portfolio assets. Active Share is the extent to which the portfolio differs from the designated Index. Payout yield is dividends plus share buybacks divided by equity. Cash flow measures the cash generating capability of a company by adding non-cash charges (e.g., depreciation) and interest expense to pretax income.
