DESCRIPTION

The Large Cap Fundamental Value Fund has invested in undervalued large cap stocks for over 30 years. These stocks represent businesses with defensible market positions, healthy balance sheets, and significant cash flow generation. We seek to build a portfolio of 40-60 stocks that offers a payout yield (dividends plus share repurchases) that exceeds that of the S&P 500 and trades with a P/E ratio below the market average.

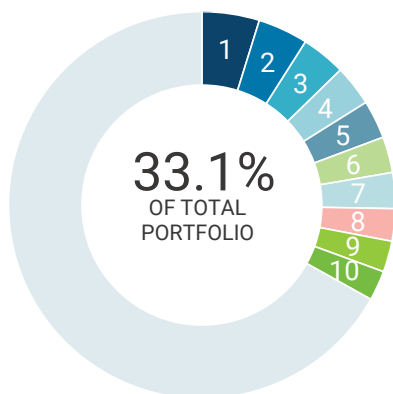

Projected earnings are consensus analyst forecasts; actual P/E ratios may differ from projected P/E ratios. **Price/Book** is the price of a stock divided by its book value. **Market Capitalization** of a company is calculated by multiplying the number of outstanding shares by the current market price of a share. **Turnover** is an annualized rate found by dividing the lesser of purchases and sales by the average of portfolio assets. **Active Share** is the extent to which the portfolio differs from the designated Index. **Payout yield** is dividends plus share buybacks divided by equity. **Cash flow** measures the cash generating capability of a company by adding non-cash charges (e.g., depreciation) and interest expense to pretax income.
