These stocks represent businesses with defensible market positions, healthy balance sheets, and significant cash flow generation. We seek to build a portfolio of 40-60 stocks that offer a payout yield (dividends plus share repurchases) that exceeds that of the S&P 500 and trades with a P/E ratio below the market average.

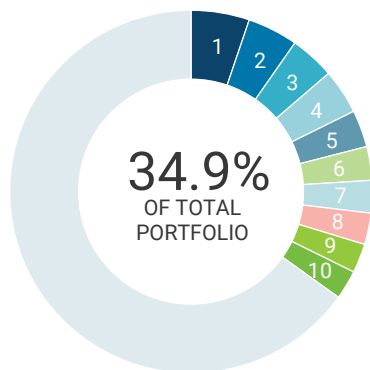
