The performance history of Firm composites prior to October 9, 2001 is comprised of the performance history of the accounts managed by the predecessor firm. There has been no material change in the investment strategy related to these products as a result of the establishment of H&W.

H&W refers to itself as a "registered investment adviser" in materials distributed to current and prospective clients. As a registered investment adviser with the SEC, H&W is subject to the rules and regulations adopted by the SEC under the Investment Advisers Act of 1940, as amended (the "Advisers Act"). **Composite**: The Composite includes all Mid-Cap Value discretionary accounts. The Mid-Cap Value investment strategy seeks capital appreciation primarily through investments in common stocks of mid-cap U.S. companies. The typical market cap range is \$500 million to \$20 billion. Accounts with significant cash flows (> 10% of beginning of the month assets for the periods January 1, 2006 through December 31, 2010, and > 25% effective January 1, 2011) are excluded from the respective month's composite calculation and included in the subsequent month. (Composite creation: 1/1/1997)

Indexes: The Russell Midcap<sup>®</sup> Value Index ("RMidcapV") measures the performance of those Russell Midcap<sup>®</sup> companies with lower price-tobook value ratios and lower forecasted growth values. The Russell Midcap<sup>®</sup> Index ("RMidcap"), an unmanaged index, measures the performance of the 800 smallest companies in the Russell 1000<sup>®</sup> Index. The indexes assume reinvestment of dividends and capital gains, and assumes no management, custody, transaction or other expenses.
