Composite: The Composite includes all Small Cap Value discretionary accounts. The Small Cap Value strategy seeks capital appreciation primarily through investments in equity securities of small cap companies and may invest in foreign (non-U.S.) securities. The typical market cap range of the strategy is consistent with the market cap range of the strategy is consistent with the market cap range of the strategy index. Accounts with significant cash flows ($\geq 10\%$ of beginning of the month assets for the periods January 1, 2006 through December 31, 2010, and $\geq 25\%$ effective January 1, 2011) are excluded from the respective month's composite calculation and included in the subsequent month. (Composite creation & inception date: 10/1/1985)

Index: The Russell 2000[®] Value Index ("R2000V") measures the performance of those Russell 2000[®] companies with lower price-to-book ratios and lower forecasted growth values. The index assumes reinvestment of dividends and capital gains, and assumes no management, custody, transaction or other expenses. The value disciplines used in managing the accounts in the Composite may prevent or limit investment in major stocks in the R2000V and returns may not be correlated to the index. Beginning December 15, 2023, the Russell 2000[®] Index, previously included on the report as a supplemental index, will be removed. Benchmark returns are not covered by the report of independent verifiers.
