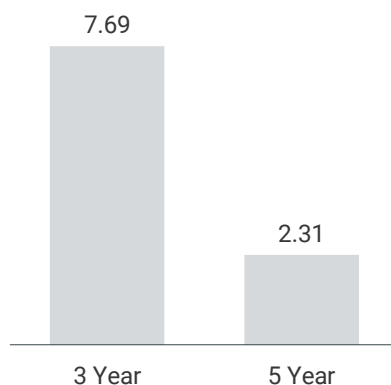

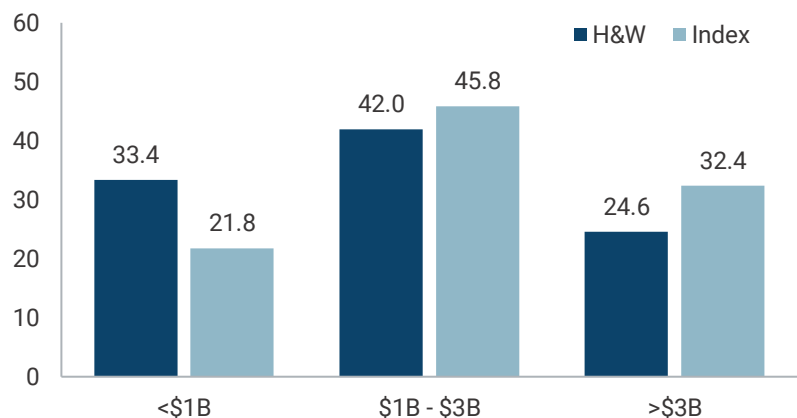
■ Fund vs. Russell 2000 Value
