

Composite: The Composite includes all Global Value discretionary accounts. The Global Value investment strategy seeks capital appreciation by investing primarily in U.S. and non-U.S. companies, which may include companies located or operating in established or emerging markets. The strategy will be based on bottom-up investment research and valuation, but will have an awareness of geographic, industry and currency exposures. (Composite creation: 7/1/2011)

Indexes: The MSCI World Index ("MSCIW") is a free float-adjusted weighted index capturing large and mid cap representation across 23 Developed Markets (DM) countries. The MSCI World Value Index ("MSCIWVal") is a free float-adjusted weighted index capturing large and mid cap representation, exhibiting overall value style characteristics, across 23 Developed Markets (DM) countries. Effective March 31, 2020, the MSCI World Value Index was added as a secondary benchmark to provide a comparable value-oriented index to the global strategy.
