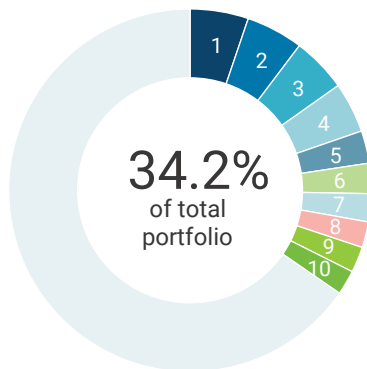

There has been no material change in the investment strategy related to these products as a result of the establishment of H&W.

H&W refers to itself as a "registered investment adviser" in materials distributed to current and prospective clients. As a registered investment adviser with the SEC, H&W is subject to the rules and regulations adopted by the SEC under the Investment Advisers Act of 1940, as amended (the "Advisers Act"). Composite: The Composite includes all Large Cap Diversified Value discretionary accounts. The Large Cap Diversified Value investment strategy seeks capital appreciation primarily through investments in common stocks of large cap U.S. companies. The typical market cap range is over \$5 billion. Accounts with significant cash flows (> 10% of beginning of the month assets for the period January 1, 2006 through December 31, 2010, and > 25% effective January 1, 2011) are excluded from the respective month's composite calculation and included in the subsequent month. (Composite creation: 4/1/2000)

Indexes: The Russell 1000® Value Index ("R1000V") measures the performance of those Russell 1000® companies with lower price-to-book ratios and lower forecasted growth values. The S&P 500® Index ("S&P") is a broad-based unmanaged index of 500 stocks, which is widely recognized as representative of the equity market in general. These stock indexes assume reinvestment of dividends and capital gains, and assume no management, custody, transaction or other expenses. The value disciplines used in managing the accounts in the Composite may prevent or limit investment in major stocks in the R1000V and S&P and returns may not be correlated to the indexes. Benchmark returns are not covered by the report of independent verifiers.

The 3-year annualized standard deviation measures the variability of the composite (using gross returns) and the benchmark(s) returns over the preceding 36-month period ended.
