



The Small Cap Diversified Value strategy seeks capital appreciation primarily through investments in common stocks of small capitalization U.S. companies. The typical market cap range is \$100 million to \$4 billion. Beginning May 1, 2020, accounts with significant cash flows (> 25% of beginning of the month assets) and greater than \$10 million in asset size are excluded from the respective month's composite calculation and included in the subsequent month. Indexes: The Russell 2000® Value Index ("R2000V") measures the performance of those Russell 2000® companies with lower price-to-book ratios and lower forecasted growth values.
