The Fund relies on in-depth fundamental research to develop a portfolio of 50-80 companies that are under-earning due to temporary factors but we believe have the balance sheet, scale, and market position to improve their performance over time.

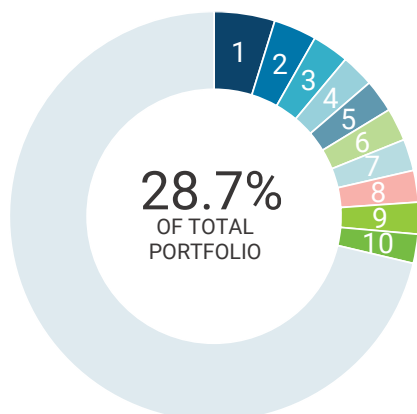
